

#### Use of Fraser Certification Service (FCS) Name and Certification Logo

#### 1. Introduction

This document provides information to the certified organization how to use the FRASER Certification Services (FCS) name and certification logo.

## 2. Rules of Use FCS Name and Certification Logo

- 2.1 The FCS name and certification logo shown in Figure 1 consist three type of standards:
  - a. ISO9001 quality management system standard (in red color);
  - b. ISO14001 environmental management system standard (in green color); and
  - c. ISO45001 occupational health & safety management system standard (in blue color)

The certified organization shall strictly follow the rules of using Fraser Certification Service (FCS) name and certification logo stated below:-

- 2.2 The format of the FCS name and certification logo shall be provided by us in electronic format upon requested from certified organization. The certified organization shall not allowed to change, including its appearance, aspect ratio, colour, shade, font style, relative sizes and positions of its components and other features. The certification logo shall be printed against a white or light colour background. It should be noted that the colour specification of the symbols shown in Figure 1 are based on a white colour background and when printing against a background of any other colour, precaution shall be taken to ensure that the colours of the logos are not affected. The logo may be enlarged or reduced in size.
- 2.3 The minimum height of the logos shall be 15mm. A smaller size is acceptable if the FCS name and certification logo is to be displayed on an item having a smaller size, e.g., name cards. Irrespective of its size, the features of the logo shall be clearly discernible.
- 2.4 The FCS name and certification logo shall not be displayed in single colour.
- 2.5 When used on paper, the FCS name and certification logo may be embossed or stamped, provided that no other modifications are made.
- 2.6 Apart from those allowed above, certified organization is not allowed to make any other modifications to the FCS name and certification logos.

## 3. Conditions on use of FCS certification logo

- 3.1 Organization certified by FCS shall not use the FCS name and certification logo in such a manner as to bring FCS into disrepute and shall not make any statement relevant to FCS which the company may reasonably consider to be misleading.
- 3.2 The FCS name and certification logo may be used by certified organization on any stationery, documents and/or publicity materials if they are related to the organization's certification scope.
- 3.3 Certified organization shall not use the FCS certification logo on its products or packaging of the products or associated documentation or certificates or in any way that may be interpreted as denoting product conformity.
  - A certified organization is not allowed to display the FCS name and certification logo in reports and certificates, which are considered as products of the certified organizations.
- 3.4 When a certified organization uses a FCS certification logo, the organization shall include its own name or logo.
